AGENT DIRECT DEPOSIT OF COMMISSIONS COMING AUGUST 2009

TSGA is happy to announce that effective August 2009 we will have the ability to **deposit your Monthly Earned Commissions directly to the bank account of your choice** via direct deposit. Many of you have expressed an interest in this convenient service and we are now ready to offer it to you! In order to take advantage of Direct Deposit of your earned commissions, you must also sign on to use our Agent ACH payment services. This will allow you, the Agent, to post your insured's payments online on a daily basis and TSGA, in turn, will **deposit your commissions** to your account **the 2nd of every month**. The benefits of using this service are numerous:

- Payment is made directly to your designated account
 - No trip to the bank to deposit the check is needed
 - No USPS mail delay in receiving your check
 - You can view and print your commission statement directly on-line as well
- TSGA will spend the month of July educating our Agents on the many payment options that we now offer. We will host a WEBINAR every Thursday at 2pm CST to explain each option and provide you with hands-on information as well as the necessary forms to fill out. **Please join us—you will be excited to see how easy it is to do business with TSGA!**

ONLINE CHECK PAYMENTS WITH NO SERVICE CHARGE

Check payments for TSGA can now be **entered online with no service charge!** Simply log on to www.texassecuritygeneral.com and select the "Make a Secure Payment Online" option. Select "EFT" from the "Select Payment Method" option box and enter the appropriate information. Again **there is no fee for the check option** when you pay online. This is a great option for agents that have chosen not to sign up for ACH Sweeps. Our online payment system accepts **all** types of checking/savings accounts. Payments will be posted to your account up to 9:59 p.m. CST. Payments entered after that time will be posted the next business day.
