ACCOUNTING NEWS

TSGA has recently enhanced our **Direct Bill payment plans**. Please note the changes listed below:

1. When selecting a payment plan with a down payment, you will now be **required to make the down payment directly** on the Status screen before submitting a quote for approval.
2. A **one-time EFT payment** can now be made directly from the Status screen to satisfy the required deposit.
3. When selecting a payment plan without a down payment, there will be no payment option available. If a payment must be made, **you must select a payment plan requiring a deposit**.
